

HOW FINANCIAL AID GETS TO YOU

Fullerton College 2021-2022 Award Year

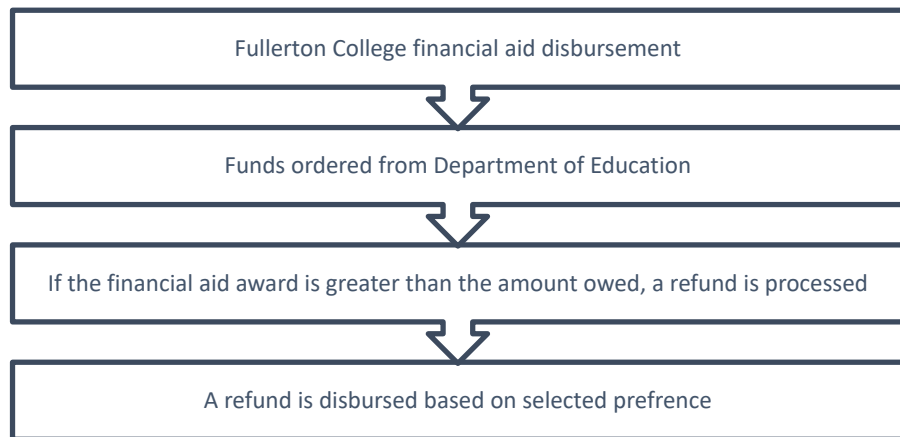
Financial aid disbursements will first be applied to any outstanding charges a student owes due to registering for classes. If a student's financial aid disbursement is **greater** than the amount the student owes for tuition, then the student will receive a refund. However, if the student's financial aid disbursement is **less** than the amount the student owes for tuition, then the student is responsible to pay the remaining fees. Students should note that not all financial aid funds are disbursable (i.e., California College Promise Grant). Financial aid will be disbursed based on number of units enrolled at the time of disbursement.

Students will receive a Refund Preference Selection Kit via email and in the mail. Students must follow the steps to choose their preference on how to receive the financial aid refund.

Electronic deposit options:

Students can find information regarding electronic deposit options online at <https://bankmobiledisbursements.com/refundchoicesso/>.

Once Fullerton College requests the funds to be sent to the student, there will be a negative amount listed on myGateway. The negative amount is the student's refund. The negative amount on the account indicates that the refund is being processed to be released to BankMobile and can take up **5 to 10 business days**.

HOW TO TRACK YOUR DISBURSEMENT

Disbursements begin the Wednesday before the first week of the semester. All eligible students who have met the priority filing date of May 28, 2021 and who meet Satisfactory Academic Progress (SAP) will be considered for the first disbursement. Once a student is awarded and registered for classes, Fullerton College must verify that the student is not receiving financial aid at another College or University, which, depending on when you register, may hold disbursement for ten days. (*See Transfer Monitoring section of the Financial Aid Consumer Brochure for more information.*) Some classes begin later in the semester, which means that the disbursement process for those classes will begin after the classes start. For details, please contact the Financial Aid Office.

Students will see a negative balance on myGateway once the disbursement process has started. After Fullerton College makes a request for payment, **it may take 5-10 business days for the refunds to be processed and transferred to the student's selected refund preference.** The negative balance will disappear from the student's account once the refund has been transferred to BankMobile. Students who are setup to receive BankMobile emails and/or text messages will be notified once the refund has been deposited into their selected refund preference.

All grant disbursements are based on the number of units in which the student is enrolled at the time of the freeze date for the semester (last day to add classes). *Note: Disbursement dates are subject to change without notice.*

October 18, 2021	Second 50% disbursement of Federal Pell Grant

SPRING 2022 DISBURSEMENT DATES	
January 26, 2022	First 50% disbursement of Federal Pell Grant
February 16, 2022	Disbursement of SEOG, Cal Grant B & C, Student Success Completion Grant, Direct Stafford Loans for returning student borrowers.
February 28, 2022	Disbursement of Direct Stafford Loans for new first-time student borrowers.
March 28, 2022	Second 50% disbursement of Federal Pell Grant

Important disbursement information:

- Students must be eligible and meet all requirements for any of the listed financial aid awards in order to receive a disbursement.
- Students must be enrolled in at least 6 units at Fullerton College or Cypress College to receive a disbursement of Federal Stafford Loan, SEOG, and Cal Grant B & C.
- Federal Stafford Loans are disbursed in two equal installments for fall and spring semesters to equal 100% of the requested amount.
- If a student is only attending Fullerton College for one semester due to completion of program, then the loan will disburse in two equal installments for the semester they are attending.
 - Disbursement dates for students attending fall 2021 only: Returning borrowers = September 8, 2021 and October 18, 2021 / New first-time borrowers = September 24, 2021 and October 18, 2021
 - Disbursement dates for students attending spring 2022 only: Returning borrowers = February 16, 2022 and March 28, 2022 / New first-time borrowers = February 28, 2022 and March 28, 2022.
- Disbursement dates for Cal Grant B & C and Student Success Completion Grant are subject to state funding.
