WHAT IS THE CCPG?

The California College Promise Grant (CCPG) is a state-wide award exclusive to California Community Colleges for California residents, including CA Dream Act students if eligible. Residency is determined by the Fullerton College Admissions & Records Office. The CCPG will waive the \$46 per unit tuition fee and a portion of the parking permit fee. Once a CCPG eligible student registers for classes, all applicable fees will be waived within 24 to 48 hours. Additional processing time may be added if documentation is required to determine CCPG eligibility.

HOW DO I APPLY?

There are two ways to apply for the CCPG.

Tips and Reminders

- Students must reapply for CCPG each academic year. It is recommended students apply for CCPG prior to the start of the fall term, however, students may apply for CCPG at any time.
- Students must apply for CCPG at both Fullerton College and Cypress College if they wish to receive it at both schools.

WHAT IF I ALREADY PAID FOR MY CLASSES BUT QUALIFY FOR CCPG?

Students will be reimbursed via check sent in the mail to the address the student has on file. Refunds may take several weeks for processing and will be mailed by the Fullerton College Bursar's Office. Students can find the refund dates online at <https://fcbursar.fullcoll.edu/>.
