FINANCIAL AID TEAM DELIVERS BIG SUPPORT IN FALL 2025 – MIDTERM MILESTONE UPDATE

The first half of the Fall 2025 semester has been nothing short of busy, and the Financial Aid Office has been hard at work helping students navigate their financial aid journey. From application assistance to one-on-one counseling, our team has provided thousands of students with critical support to help them stay enrolled and on track.

Between August 18 and October 6, 2025, the Financial Aid team has already had over 6,400 student interactions across multiple service areas – a testament to our ongoing commitment to student success.

By the Numbers – Fall 2025 (So Far!)
Here's a quick look at what's been
accomplished during just the first half
of the semester:

- 3,482 students checked in at the Financial Aid counter to ask about their award status, disbursements, next steps, and more.
- 2,314 students requested a financial aid callback through our QLess system, receiving timely updates and assistance without having to wait in long lines.



- 450 students received in-person help in the Financial Aid Computer Lab, where staff guided them through FAFSA and CADAA applications, Student Forms setup, CCPG application, BankMobile activation, and various other tasks on myGateway such as checking their account balances, showing students where to find their class schedules and their unofficial transcripts.
- 219 students met with a Financial Aid Counselor to discuss more indepth topics like Satisfactory Academic Progress (SAP) Education Program Plan (SEPP), and get assistance with the SAP appeal process.

These numbers represent more than just stats – they reflect real student stories and real moments where our office helped students move one step closer to their goals. Whether it was clearing up confusion about a missing document, walking through an application line-by-line, or helping a student regain their aid through a SAP

appeal, the Financial Aid team continues to play a vital role in student retention and academic success.

Behind every number is a dedicated team member who made it possible. From the front counter to phone callbacks, lab assistance to one-onone counseling, the Financial Aid team is proud that our numbers reflect we are going above and beyond for Fullerton College students.

As we move into the second half of the semester, the work continues, and we remain committed to providing excellent service, clear disqualifications, receive a Student communication, and compassionate support for every student who walks through our doors (or requests a callback or sends an email!).



2026-2027 FAFSA AND CA DREAM ACT APPLICATIONS NOW OPEN!



The 2026-2027 **FAFSA** and **California Dream**

Act Applications (CADAA) are now available! If you plan to attend college between July 1, 2026, and June 30, 2027, apply early to be considered for the maximum amount of financial aid, including grants, scholarships, and work-study. Visit <u>studentaid.gov</u> for the FAFSA or <u>dream.csac.ca.gov</u> for the CADAA.

It's also not too late to apply for the 2025-2026 academic year – both applications remain open until June 30, 2025. If you haven't applied yet, there's still time!

SATISFACTORY ACADEMIC PROGRESS (SAP) – CHANGES TO THE APPEAL PROCESS IN FALL 2025

While the Satisfactory Academic Progress (SAP) Policy remains the same, the SAP appeal process has been updated this semester to make it more accessible and efficient for students. These changes are designed to ensure that all students who wish to appeal have the opportunity to do so – especially in light of limited Financial Aid Counseling appointment availability.

Policy Reminder: What is SAP?

Students must meet the following standards to remain eligible for most types of financial aid:

- 2.0 cumulative GPA or higher
- Completion of at least 67% of all attempted units
- Completion of a program within 150% of its published unit length (e.g., 90 units for a 60-unit AA/AS degree)

SAP is reviewed at the end of each semester and applies to all coursework, even if financial aid was not received.

What's New: Streamlined Counseling Requirements

To simplify the process and reduce wait times, only some students are

SAP Requirements

- Complete at least 67% of all attempted units
- Maintain a cumulative
 2.0 GPA or higher
- Be below a total of 90 units

required to meet with a Financial Aid Counselor before submitting a SAP appeal.

An appointment is required if:

- The student has attempted 90 or more units, or
- The student is changing from one certificate program to another that is under 60 units

Appointments can be scheduled online (via the link in the SAP disqualification notification) or in person at the Financial Aid kiosks.

An appointment is NOT required if:

- The disqualification is due to a GPA below 2.0, or
- A completion rate below 67%, or
- The student is switching from a certificate program to a 60-unit degree (AA/AS)

Submitting a SAP Appeal

All appeals must be submitted online at https://fullcoll.studentforms.com. Each appeal must include:

- A personal statement explaining why SAP standards were not met
- Documentation of any extenuating circumstances
- A Student Educational Program Plan (SEPP) if required (see counseling requirements above)

Need Help? We're Here for Support!

The Financial Aid staff are here to help every step of the way. Students who need assistance with submitting their SAP appeal or uploading documents can receive in-person support at the Financial Aid Computer Lab during our open business hours. Also, as part of our Financial Aid Friday workshops, we will host workshops on the topic of SAP. Our next SAP workshop will be on November 14, 2025.

STAY AID ELIGIBLE: TAKE CLASSES THAT COUNT

What Is CPoS?

Course Program of Study (CPoS) is a federal regulation that requires students to take classes that apply to their officially declared major, degree, or certificate program in order to qualify for financial aid. Under CPoS, if a course does not count toward a student's program of study, it may not be eligible for Pell Grants, Federal student loans, Cal Grant, Student Success Completion Grant (SSCG), and more.

This means students will need to stay on track with their academic plan both to graduate on time and to receive their full financial aid package.

Why It Matters

In the past, students could take a variety of courses, even those not related to their major, without losing financial aid eligibility. With CPoS, financial aid will now be calculated based only on classes that directly support a student's educational goal.

If a student enrolls in courses outside of their declared program, those units won't be counted toward their financial aid enrollment status. This could result in receiving less financial aid if not enrolled in courses directly related to the student's program.



How Students Can Prepare

Although CPoS won't officially begin until Fall 2026, there are steps students can take right now to stay ahead:

Review and Update Program of Study

Students should check their declared major or program to ensure it reflects their current academic and career goals. If it needs to be changed, they should meet with an academic counselor as soon as possible.

2. Follow an Updated Educational Program Plan

Having a current Student Educational Program Plan (SEPP) is critical. This plan outlines the courses needed to complete a student's program and ensures those courses are eligible for financial aid under CPoS rules.

3. Be Strategic During Registration

Before registering for each semester, students should confirm that all selected courses align with their SEPP. Courses that aren't part of the plan may not be covered by financial aid.

4. Stay Informed

The Financial Aid Office will continue to share updates as more guidance is released. Students should keep an eye on their email, check the Financial Aid website, or stop by in person closer to the start of the fall 2026 semester.

When It Starts

CPoS will be implemented beginning Fall 2026, for the 2026-2027 financial aid year. While that may seem far off, preparing early will help students avoid last-minute surprises and stay fully eligible for aid.

NO SUMMER SLOWDOWN: FINANCIAL AID OUTREACH POWERS INTO FALL 2025

Summer may have come and go, but the Financial Aid Outreach team has remained busy on and off campus getting our incoming and continuing Fullerton College students financial aid ready for Fall 2025 - Spring 2026 academic year. Changes in financial aid may be ongoing and more of the norm, therefore, the Financial Aid Outreach team continues to work with partners on and off campus to keep the information consistently updated during presentations, workshops, and tabling events to ensure students and staff alike are informed on current eligibility and processes.

With 25 events already on the books, Financial Aid Outreach has already serviced 2,511 individuals with 21 additional events scheduled through the end of Fall and counting.

The team takes a proactive approach during these events to ensure a smooth process navigating the application process through the verification process and all the way until students are disbursed any awarded grants.

START sessions with High School Outreach kicked off the Summer to Fall transition with over 1700 in attendance. Financial Aid Outreach presented in the Fullerton College campus theatre "Next Steps for Financial Aid" prior to students going to different stations depending on where they were in the registration process. Students that still needed financial aid assistance went to dedicated Financial Aid workshops where the Financial Aid Outreach team was able to help students complete pending financial aid files, complete the application process itself, set up their Student Forms account and BankMobile refund preferences, and how to find their Financial Aid award letters on their myGateway accounts.





For students not able to finish during the START sessions or that needed additional

support, Future Hornet Sessions throughout the month of August up until census date in September brought additional opportunities for Financial Aid Outreach to get students on track to receiving their financial aid on time. These workshops allowed space for students to ask further questions about their financial aid and even catch some errors early on to be able to resolve timely for the first Fall disbursements.

The Financial Aid Outreach team continues to collaborate with other programs on campus tailoring the needs of the population of students they serve. Grads2Be invited the team for a workshop focused on FAFSA and CADAA explaining differences between the two applications and the eligibility for different types of awards available. Additionally, the team has been providing financial aid training presentations for the Student Success Advocates to better service our students and help overcome barriers students may face when planning to continue their education.

Our partners from the Fullerton Joint Union School District held their College Fair at Sonora High School. Financial Aid Outreach met with 77 individuals that night looking at

community colleges as an option for their family members or themselves in the coming years. Junior high and high school students had the chance to start looking at the financial aid options that may be available to them after high school and take home flyers with important information such as steps to financial aid and how to contact the Financial Aid Office for further information. La Habra High School also has a dedicated Financial Aid Night coming up for their students where Financial Aid Outreach will provide a presentation and workshop to follow.

A new addition this Fall for the team is the Financial Aid Fridays workshop series scheduled for every Friday during the Fall term. With topics specifically designed to tailor the requests and demand the Financial Aid Outreach team sees when servicing students at events, such as Satisfactory Academic Progress, Cal Grant and Student Success Completion Grant, Changes in Financial Aid, and Financial Literacy just to name a few.

These ongoing efforts to continue improving outreach and in-reach efforts while collaborating with partners on and off campus are a part of the Financial Aid Outreach team's goal in helping students enroll and stay enrolled to finish their academic goals. While the Fall 25' semester may be in full swing, the 2026-2027 FAFSA and CADAA application now being open brings more opportunities for the team to assist students at events looking to continue their education.

 providing information about
 available aid, eligibility, and the
 application process under state
 law.
- FAFSA & CADAA Updates –
 Upcoming changes to the financial aid process for the 2026–2027 academic year, including new deadlines, policy updates, and application tips.
