



California College Promise Grant

WHAT IS THE CCPG?

The California College Promise Grant (CCPG) is a state-funded program available exclusively to California residents attending California Community Colleges, including eligible CA Dream Act students. Residency status is determined by the Fullerton College Admissions & Records Office. The CCPG covers the \$46 per unit tuition fee and part of the parking permit fee. After registering for classes, eligible students will have all applicable fees waived within 24 to 48 hours. Please note that additional processing time may apply if further documentation is needed to confirm eligibility.

HOW DO I APPLY?

OPTION 1 FAFSA or CADAA (recommended option for all students)

All students are encouraged to apply for financial aid through either the FAFSA or CADAA, which includes consideration for the California College Promise Grant (CCPG). If you qualify, the CCPG will cover your enrollment fees.

IMPORTANT: Students should submit only one financial aid application, as submitting both will delay processing.

OPTION 2 CCC Apply CCPG Application (continuing students)

Continuing students can submit the CCC Apply CCPG Application through myGateway.

1. Log into your myGateway account.
2. Navigate to Student Tools and select Financial Aid.
3. Under General Links, click on Fullerton College CCPG Application.
4. Sign into your CCC Apply account (do not create a new account).
5. Click on Start New Application and follow the provided instructions.

NOTE: You may need to submit supporting documentation to verify your CCPG eligibility.

OPTION 3 CCC Apply CCPG Application (new students)

New students can submit the CCPG Application through CCC Apply.

1. Visit CCC Apply at home.cccapply.org.
2. Under Apply, select California College Promise Grant.
3. Select Fullerton College.
4. Sign into your existing CCC Apply account (create an account if you do not already have one).
5. Click on Start New Application and follow the provided instructions.

NOTE: You may need to submit supporting documentation to verify your CCPG eligibility.

TIPS & REMINDERS

- Students are required to reapply for the CCPG each academic year. While it is advisable to submit the application before the beginning of the fall term, students can apply for the CCPG at any point throughout the academic year.
- To receive the waiver at both Fullerton College and Cypress College, students must apply for the CCPG at each institution.

WHAT IF I ALREADY PAID FOR MY CLASSES BUT NOW QUALIFY FOR CCPG?

Students will receive refunds by check mailed to the address on file. Please note that refunds may take several weeks to process and will be sent by the Fullerton College Bursar's Office.
